Head of Engagement Report

FACES

Now have 150 people signed up (I reported 140 in January). Further updates:

- Sara hosted the FACES panel session at the Local Authority Property and Estates conference in Manchester last month. Was well received again.
- RICS APC training day was held at LSH offices in London on February 6th.
 Again well received and LSH did us proud.
- The online "Ask the expert" Teams session in March was attended by 40 from the ACES community. Sara Cameron, Bernard White, Helen Stubbs and Georgi Hill from RICS joined me in answering questions. Plans are afoot to host another one possibly focused on "how to think as a surveyor, and not just as a public sector surveyor".

EG Public Sector Forum

At the time of writing, the draft the document is with the Estates Gazette for editing. This initiative is with Estates Gazette, Jackie Sadek, Local Partnerships and six local authority CEOs. Sara and I will have attended the last meeting on April 18th prior to joining the launch event at UKREiiF at 15.00 on May 22nd.

Offices for Good

We have now held two webinars (at the time of writing), three by the time you read this. The first featured our Fellow, Jackie Sadek talking about the vitality of places and how that relates to offices.

The second had our very own President plus Alice Stacey from DLUHC talking about some of the drivers behind office changes and what pressures the public sector faces.

The third, on April 18th will focus on Culture and features the Maxine O'Mahoney and Ralph, Burton, CEO and Head of Property at Breckland Council plus Gordon MacFarland and Steve Davies, the President and Secretary of the PPMA (HR professionals).

The fourth and final one on 9th May should feature GPA and Remit looking at the use of data and benchmarking.
