

Head of Engagement Report to Council July 2025

RICS

Two days prior to Council, Dan and I are attending the RICS Public Sector Forum which Dan is chairing. The two key items we are promoting are:

1. CEO/CMT support for a property profession in authorities and recognition of RICS/ACES. Considering approaching a range of CEOs to get their views on property functions in authorities and support for professional subscriptions.

2. outplacements for APC candidates in partner organisations. I am in discussion with Lara Newman about writing to our respective private sector partners so see what they offer in terms of outplacements for APC candidates struggling to find certain experience for their APC.

We have prepared the key members of the Forum so hope to have a focus on actions rather than just a discussion. All of this is in the background of Local Government reform. We will report further on this at Council.

NB Morag Angus, also an ACES member is chairing the September event in her role as Chief Surveyor (Scotland).

MHCLG's Pathways to Property initiative

We have been supporting MHCLG and the LGA in their development of the property equivalent of Pathways to Planning. The planning version was established in 2023 to increase and diversify the pipeline of graduate talent coming into local planning authorities in England. By September 2025, the programme will have recruited more than 200 graduates to work as planners in local councils and complete RTPI accredited master's degree alongside work.

Their next campaign, launching in September 2025 for positions starting work in September 2026, will be recruiting graduates into surveying and construction project management roles within local authorities. The programme uses a job-predictive assessment process to find the best candidates for the job, designing tests based on input from high achievers currently working within the roles. I have asked the FACES community and members via eBrief to source some people who could spare an hour or two of their time to help their consultant occupational psychologist develop assessments this summer/autumn, please complete the simple form here It is probably best suited to those who have been in post for two or more years.
